- 1. Discussion/Action: Swearing In of New Trustee

- 2. Discussion/Action: Allocation of Funds for Special Events Monies Received Lauren, the head of the Special Events Committee, talked about what they need for July 4th festivities. Money, food, rental of a bounce house versus buying a bounce house for the Village, the cost of the band and the DJ, the cost of food.  diamond down 1st Street will be closed for the Village 4th of July festivities.
- 4. Discussion/Action: Review of Invoice Received from the IT Contractor John brought the invoice from the IT Contractor up for discussion. It was more money than originally approved by the board at the May 13, 2025 meeting. It was estimated to be around \$400.00 more than the bid. Josh made motion to approve and accept the invoice for payment. Billie Rae seconded the motion. By Roll Call Vote, 6 Yes's, 0 No's, 0 Absent. Motion carried to pay the increased invoice received with the difference in amount from the IT Contractor.
