"An Ordinance Declaring Surplus Property and Authorizing Sale of the Same"

PREAMBLE

**WHEREAS**, the Village of Hammond, Piatt County, Illinois, (hereinafter the "Village") is a duly established and functioning municipality in Piatt County, Illinois; and

**WHEREAS**, the Village owns and possesses items listed on the attached Exhibit A, which said Exhibit is incorporated herein by reference (hereinafter the "Items");

**WHEREAS**, said Items are no longer necessary or useful to the Village or in the best interest of the Village to retain ownership thereof; and

**WHEREAS**, the Village does hereby desire to declare the Items as surplus property and to dispose of the same pursuant to Ordinance authorizing the same;

**NOW, THEREFORE, BE IT ORDAINED** by the President and Village Board of the Village of Hammond, Piatt County, Illinois, that:

**ARTICLE ONE  
SURPLUS DECLARATION**

The aforementioned Items are hereby declared surplus property.

**ARTICLE TWO  
SALE OF ITEMS**

The Village President is hereby authorized and directed to sell the Items at the best available price and by the most advantageous or convenient method, including, but not limited to, making the Items available for salvage, in the Village President's sole discretion, and to execute any and all documents necessary for the conveyance of ownership of the Items to the buyer. The Village President may delegate authority to any officer, employee, or individual to assist in the selling of the Items and perfecting their sale.

**ARTICLE THREE  
SEVERABILITY**

Should any part of this Ordinance be declared invalid by a court of competent jurisdiction, such declaration shall not affect the validity of the remaining portions of this Ordinance.

**ARTICLE FOUR  
EFFECTIVE DATE**

This Ordinance shall be in full force and in effect immediately upon its passage and approval. The Village Clerk shall cause notice to be published by posting a notice in three prominent places within the Village of Hammond, or by other means allowed by statute.
