BE IT ORDAINED by the President and Board of Trustees of the Village of Hammond, Piatt County, Illinois, that:

SECTION 1: PROHIBITION OF TEMPORARY STORAGE CONTAINERS. The placement, maintenance, or affixing of a temporary storage container on Village property is prohibited. For the purposes of this Ordinance, “temporary storage container” shall include, but is not limited to: any conversion of a trailer coach, travel trailer, camper vehicle, manufactured/mobile home, semi-trailer container, semi-trailer, storage trailer, storage container, shipping container, enclosed box trailer, or any other free-standing trailer or container into a building, structure, or storage apparatus. A temporary storage container may be placed on property within the Village by a licensed contractor in connection with an ongoing construction project. Under no circumstances shall said placement extend beyond a period of fourteen (14) continuous days, including weekends and holidays. All contractors must obtain a written permit from the Village prior to placing a temporary storage container on property within the Village.

SECTION 2: PENALTIES. Any person, firm, trust, association, or corporation, who violates this Ordinance shall be fined per the following:

- 1st Offense: \$180.00
- 2nd Offense-committed within 12 months of any prior offense: \$330.00
- 3rd Offense-committed within 12 months of any prior offense: \$580.00

Each day that a violation continues shall be deemed a separate offense.

Notice shall be deemed to be properly served by:

- a. Depositing the notice in U.S. mail, prepaid first-class postage regardless of whether the addressee accepts or refuses delivery; or
- b. Personal service; or
- c. Posting of notice upon property.

This Ordinance shall be in full force and effect forthwith upon its passage and approval, as required by law.
