**BE IT ORDAINED** by the President and the Board of Trustees of the Village of Hammond, Piatt County, Illinois:

**SECTION 1:** That the following sums be and the same are hereby appropriated to pay all necessary expenses and liabilities of the Village of Hammond, Piatt County, Illinois, for the fiscal year beginning May 1, 2023 and ending April 30, 2024, such appropriations being made for the following objects and purposes:

**SECTION 2:** At any time after the first half of fiscal year 2024, by a vote of two-thirds of the Board of Trustees and President, the sums hereby appropriated may be transferred within any department of the Village and the sums appropriated for a corporate object or purpose may be transferred to another corporate object or purpose, but no appropriation for any object or purpose shall hereby be reduced below an amount sufficient to cover all obligations incurred or to be incurred against such appropriation.

**SECTION 3:** Should any additional revenue become available to the municipality during fiscal year 2024, the President and the Board of Trustees may adopt a supplemental Appropriations Ordinance in the amount not to exceed the aggregate of such additional revenue available or estimated to be received by the Village during fiscal year 2024. Such supplemental Appropriations Ordinance shall only affect revenue not available for appropriation when this annual Appropriations Ordinance was adopted.

**SECTION 4:** Should any section or provision of this Ordinance be declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of the Ordinance, which shall remain in full force and effect.

**SECTION 5:** This Ordinance shall take effect and be in full force from and after its passage and approval, and publication in pamphlet form as required by law. Any and all prior Ordinances not in conformity herewith are hereby revoked and declared null and void.
