ORDINANCE 2024-17

WHEREAS, The American Rescue Plan Act provides for State and Local Fiscal Recovery Funds, a definition which includes The Village of Hammond, Illinois, and

WHEREAS, the Village of Hammond has defined a strategy for the use of American Rescue Place Act State and Local Fiscal Recovery Funds to repair, replace, or improve government services, and

WHEREAS, in January 2022, the U.S. TREASURY issued U.S. TREASURY FINAL RULE AND GUIDANCE FOR STATE AND LOCAL FISCAL RECOVERY FUNDS (31 CFR Part 35 RIN 1505-AC77) henceforth U.S. TREASUARY FINAL RULE, and

WHEREAS, the U.S. TREASURY FINAL RULE, enables The Village of Hammond, Illinois to use available ARPA STATE AND LOCAL FISCAL RECOVERY FUNDS for “*a broad range of government services, programs, and projects outside of typical eligible use of recovery funds under the final rule*” and in accordance with cited restrictions defined in the U.S. TREASURY FINAL RULE.

WHEREAS, the Coronavirus State & Local Fiscal Recovery Funds: Overview of the Final Rule / U.S. Department of the Treasury / January 2022 defines Government Services as generally including “any service traditionally provided by a government, including construction of roads and other infrastructure, provision of public safety and other services, and health and educational services.” Funds spent under government services are subject to streamlined reporting and compliance requirements.

NOW THEREFORE, the Village of Hammond, Illinois Treasurer shall make American Rescue Plan Act, State and Local Fiscal Recovery funds available and shall properly record such distribution as follows:

1. An amount not to exceed Thirty-Nine Thousand, Eight Hundred and One Dollars and Thirteen Cents (\$39,801.13) shall be made available for the purpose of purchasing materials and services necessary for the repairs, enhancements and/or upgrade of the Village’s water meter system in the Village of Hammond, Illinois.
2. An amount not to exceed Three Thousand, One Hundred Eight Dollars, and Eighty-Nine Cents (\$3,108.89) shall be made available for the purpose of purchasing materials and services necessary for the repairs, enhancements and/or upgrade of the Village’s water meter system in the Village of Hammond, Illinois.
3. Funds shall be fully obligated before December 2024 and all work completed and funds expended no later than December 2026.
