## VILLAGE OF HAMMOND PIATT COUNTY, ILLINOIS ORDINANCE NO. 2025-01

#### **PREAMBLE**

**WHEREAS**, the Village of Hammond, Illinois (hereinafter the "Village") is a duly established and functioning municipality in Piatt County, Illinois; and

**WHEREAS**, the Village has determined it necessary to codify and establish its practice of compensation for attending Village Board meetings.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND VILLAGE BOARD OF THE VILLAGE OF HAMMOND, PIATT COUNTY, ILLINOIS, THAT:

## ARTICLE I TRUSTEE COMPENSATION

Effective May 2025, each Village Trustee shall be compensated for each meeting of the Village Board actually attended at the rate of \$45.00 per Village Board meeting. The President shall be compensated for each meeting of the Village Board meeting actually attended at the rate of \$65.00 per Village Board Meeting. The President or a Trustee shall not be paid for a meeting for which he or she did not attend.

## ARTICLE II FAILURE TO ATTEND MEETINGS

If any Trustee fails to attend the regular meetings of the Village Board on three (3) successive occasions, unless such absences have been excused because of illness or circumstances beyond the absent Trustee's control, the seat of the Trustee shall be deemed vacant the same as though the Trustee had resigned from his/her office. Any Trustee wishing to avail himself/herself of the exemption provided, shall file in writing with the Village Clerk, not later than 24 (twenty-four) hours prior to the third successive Village Board meeting from which he/she proposes to be absent, his/her reasons for absenting himself/herself.

## ARTICLE III EFFECTIVE DATE

The Ordinance shall be in full force and in effect immediately upon it passage and approval. The Village Clerk shall cause notice to be published by posting a notice in three prominent places within the Village of Hammond, or by other means allowed by statute.
