Call to order at 7:02 pm

Swearing in of newly elected Trustees: 2-year Unexpired Term-Donald Chenoweth; 4-year Term-Michael Brown, Bradley Frantz, Kimberly Gee.

Roll call: President Debby Waldrop-here, Marsha Burgener-absent, Kim Gee-here, Mike Brown-here, Brad Frantz-here, Don Chenoweth-here, Jon Parsons-here

Public Comment: Brandy Diaz was present to answer any questions the Board may have regarding her request to conduct Fitness Classes in the building. She is currently checking on insurance. Monthly charge of \$35 per member. Classes to be held five days per week. May do some outdoor classes. Possibly do on a trial basis (3 months) or month-month. She is open to making a deposit for the use of the building. She's to purchase an AED machine. If building is rented or there is a Board Meeting, she'd have to make other arrangements. The Board is open to the idea, but she must have proof of insurance first before anything is decided.

Clark Cameron with IRWA was present to go over the current rate study he completed. Tries not to raise base rate, but rather consumption. His recommendation is to add \$2.00 per thousand gallons each year for the next two to three years. He suggested the Board adopt an ordinance raising the consumption rate by 3% each year (cost of living). It wouldn't come as a surprise to the residents if it's already built into the ordinance.

April 10, 2019 Board Meeting Minutes: Jon made the motion to approve with a 2nd by Kim. All in favor; motion carried. April 17, 2019 Special Board Meeting Minutes: Donnie made the motion to approve with a 2nd by Brad. All in favor; motion carried.

Financials: Brad made the motion to approve with a 2nd by Kim. Roll call vote: Donnie-yes, Marsha-absent, Kim-yes, Brad-yes, Jon-yes, Mike-yes. 5 ayes, 1 absent; motion carried.

Recommendations of the Committee(s): It was decided that liquor would be allowed in the Community Building, but only with proof of insurance showing the Village of Hammond as additional insured. 4-yes, 1-no, 1-absent. Mike made the motion to raise the annual golf car fee from \$25.00 to \$40.00, with a 2nd by Brad. Roll call vote: Marsha-absent, Kim-yes, Brad-yes, Jon-yes, Mike-yes, Donnie-yes. 5 ayes, 1 absent; motion carried. Mike has agreed to inspect the golf cars and Brad will be his backup. Jon made the motion to split the cost of clean up day with IV Container, amount not to exceed \$500.00, with a 2nd by Kim. Roll call vote: Kim-yes, Brad-yes, Jon-yes, Mike-yes, Donnie-yes, Marsha-absent. 5 ayes, 1 absent; motion carried. Need to check with David Chapman, Unity Township Supervisor to see if he may possibly help pay for our share. Mike made the motion to increase the cleaning of the water tower from \$4,000 to \$5,000, with a 2nd by Jon. Roll call vote: Brad-yes, Jon-yes, Mike-yes, Donnie-yes, Marsha-absent, Kim-yes. 5 ayes, 1 absent; motion carried.

Brad made the motion to pass Resolution #2019-002, "Resolution Concerning the Review and Release of Executive Session Minutes and the Destruction of Executive Session Audio Recordings", with a 2nd by Jon. Roll call vote: Jon-yes, Mike-yes, Donnie-yes, Marsha-absent, Kim-yes, Brad-yes. 5 ayes, 1 absent; motion carried.

- Vandevanter Engineering Preventative Maintenance Contract Proposal: Annual cost of \$1,958.00. Ronnie would like to have this in place. It was the consensus of the Board to see if they'd come out and look over the lift stations without a contract.
